2023 Cancer Genomics Consortium Annual Meeting August 13 - 16, 2023

The CGC Annual Meeting is a preeminent annual gathering for laboratorians, clinicians and researchers with a shared interest in early adoption, performance and interpretation of leading-edge technology for cancer and constitutional genomics. The collegiality of the CGC provides a unique educational opportunity for all to advance clinical diagnostics using genomic technologies (FISH, microarray, massively parallel sequencing, etc.) and to improve the data processing that accompanies these technologies.

In 2022, the CGC hosted its first hybrid meeting with more than 450 participants representing 17 countries. More than 320 people joined us in St. Louis – a record in-person attendance for the CGC, and an additional 138 people joined the meeting virtually. This summer, we will continue the **hybrid (in-person + virtual)** format that will feature in-person platform presentations, workshops, networking sessions, an exhibit hall, poster sessions, round table discussions, and other interactive opportunities with our industry supporters. We will <u>also</u> provide virtual content streaming, live virtual Q&A, and CME and PACE credit for all attendees.
